Sub: Conduct of Under 19 Men Selection trial matches for domestic season 2025-26.

Dear All,

With reference to the subject cited above, I would like to inform you all that Meghalaya Cricket Association will be conducting the selection trial matches for the Under 19 Men category- **registered players** from the **20th to 30th July 2025** and followed by trials for **fresh players** as recommended by the district associations, from the **31st July to 3rd August 2025 at Jagiroad, Assam**. Attached with are the fixture and rules and regulations of the trial matches which are for your kind information. List of the registered players who have been divided into 5 teams for attending the selection trial matches is also attached herewith and list of fresh players attending the trials from 31st July to 3rd August 2025 will be shared in due time.

This will be the first phase of trials and followed by consecutive trials as part of the selection process which will happen subsequently. MCA will appoint a coach as part of the supporting staff during the course of the trials to help with the team combinations during the given matches.

Accommodation for players coming from other districts will be arranged by MCA at Shillong and details of the same will be shared in due time. MCA will also be arranging transportation for players for going to Jagiroad and back to Shillong on match days. Further, kindly note players will report at Shillong one day prior to their matches and will depart the next day of their match. We would request the districts to kindly inform the players to report accordingly, MCA will not be responsible for their early reporting. However exception will be provided to players who will be playing matches with a minimum gap of one day only before their next match.

Also, if incase of any player not available for attending the said trials, player/s or the concern district association may inform MCA about the inavailability of the players by sending a mail to MCA with reasons of being absent on or before 15th July 2025. Kindly note any player not attending the trials matches will not be considered for the next phase of trials.

**Rules and Regulations for the Trial matches for Under 19 Men
organised by Meghalaya Cricket Association from 20th July to 3rd
August 2025 at Jagiroad Cricket Ground Assam.**

Apart from the normal laws of cricket approved, the following additional rules and regulations for the smooth and proper conduct of the trial matches: -

1. Proper dress code i.e (White dress / T-shirt with collar/ Trouser/ Socks / White sneaker/ White boots) should be worn by the players.
2. Teams should report at least 30 minutes before the schedule start of play and offer themselves for verification.
3. Matches will be of 50 overs a side.

Schedule of play :

Reporting – 8:00 am.

Breakfast – 8.30 am.

Toss – 9:00 am.

1st Session– 9.30 am to 1:00 pm (including 2 drinks break of maximum 5 minutes each after completion of 17th and 34th overs)

Lunch Break - 1:0 pm to 1:40 pm.

2nd Session – 1:40 pm to 5:10 pm (including 2 drinks break of maximum 5 minutes each after completion of 17th and 34th overs)

4. MCA will depute observers for the match i.e, Selectors/ Coaches/ Umpires/ Scorers etc.
5. Instructions given by the Observers / Selectors / Coaches in the ground should be strictly followed by the players.
6. Discipline and decorum on and off the field should be maintained by all the players which also shall be noted for selection process.
7. Management shall have the right to amend or modify any of the rules as and when necessary in the interest of the selection process and decision of the management shall be final and binding.
